I TAPAN BADKUL, Practicing Cost Accountant have been appointed as the Scrutinizer by the Board of Directors of the Narmada Gelatines Limited via Circular Resolution passed on 19th November, 2025 for conducting the Postal Ballot/ E-Voting process in a fair and transparent manner and in accordance with the Companies Act, 2013 and Rules made there under.

Pursuant to Sections 108, 110 of the Companies Act, 2013 ("the Act") read with Rules 20 and 22 of the Companies (Management & Administration) Rules 2014 ("the Rules"), the Secretarial Standard-2 on General Meetings issued by the Institute of Company Secretaries of India ("SS-2"), read with the General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, and subsequent circulars issued in this regard, the latest being 9/2024 dated September 19, 2024, issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as 'MCA Circulars'), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations') and other applicable provisions of the Act, rules, regulations, circular and notification (including any statutory modification(s), clarification(s), substitution(s) or re-enactment(s) thereof for the time being in force), the Resolution as set out hereunder is proposed for approval of the Members of Narmada Gelatines Limited ('the Company') as an **Special Resolution**, by way of Postal Ballot only through Remote e-Voting i.e. voting through electronic means ('Remote e-Voting').

Pursuant to Section 102 and 110 and other applicable provisions of the Act and SS-2, the Explanatory Statement pertaining to the said resolution setting out the material facts and related particulars were set out in the Notice dated November 19, 2025.

Accordingly, the Company has sent the Notice including all the requisite information to cast vote, in electronic form, to all its Members who had registered their email IDs with the Company/Registrar & Transfer Agents/ Depository Participants. The Communication of the assent or dissent of the Members was sought through the e-

voting system only. In order to facilitated those Members who had not registered their email IDs, a proper procedure was laid down to get their email IDs, registered with the RTA so that they could also participate in the e-voting facility extended by the Company.

The aforesaid notice was sent on November 21, 2025 through email to all the Members who held shares of the Company as on Friday, November 14, 2025 (i.e. Cut-off date) for voting favour or against of the following Resolution:

The Following Resolution as a **Special Resolution**:

"RESOLVED THAT pursuant to Regulation 17(1A) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (including any statutory modification, amendment or re-enactment thereof for the time being in force) and other applicable laws, if any, and as recommended by the Nomination and Remuneration Committee and the board, the consent of the members of the Company, be and is hereby accorded for continuation of directorship of Mr. Kailasam Krishnamoorthy (DIN: 02797916), as a Non-Executive Independent Director of the Company, who is going to attained the age of 75 years on 26th December, 2025 as long as his 1st tenure of independent director shall continue i.e. till the conclusion of 65th AGM of the Company or 20th September, 2026, whichever is earlier.

RESOLVED FURTHER THAT any of the Director of the Company or the Company Secretary of the company, be and are hereby severally authorized to sign and submit necessary forms with the ROC and do all such acts and deeds as may be necessary in this regard."

The Company and the CDSL has uploaded the Notice together with the explanatory statement on their respective websites www.narmadagelatin.com and www.cdslindia.com. The Notice was also uploaded on the Stock Exchange website where the securities of the Company are listed i.e. www.bseindia.com. Electronic Voting Sequence Number "251120007" (EVSN) was generated for casting the votes through e-voting mode. The Company and CDSL have complied with all the necessary formalities specified under the Act, the Rules and the Circulars issued in this regard.

I report that, the Notice was sent through e-mail to the Members whose email IDs were registered with the Company/ Depositories and as made available and provided by the M/s CB Management Services (P) Limited (RTA). The total number of Members as on the Cut-off date i.e. November 14, 2025 was 7770. A public Notice with regard to the Company's Postal Ballot was published on November 22, 2025 in "Hitavada (English daily) and Deshbandhu (Hindi daily) newspaper".

The Remote E-Voting had commenced on Tuesday, November 25, 2025 at 9.00 a.m. IST and will end on Wednesday, December 24, 2025 at 5.00 p.m. IST. Remote E-Voting was blocked by CDSL as authorized by me immediately thereafter and was not allowed beyond the said date and time.

The Management of the Company is responsible to ensure the Compliance with the requirement of the Act, 2013 and Rules made thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, as applicable relating to the voting through Remote E-Voting on the Special Resolution mentioned in the Notice dated November 19, 2025.

My responsibility as scrutinizer for the remote e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolution based on the reports generated from the Postal Ballot process and the Remote E-Voting system provided by CDSL.
